## KYPRIA INTERNATIONAL FESTIVAL 2019

## OPEN CALL FOR PROPOSALS

The Artistic Director of the KYPRIA International Festival is issuing an international open call for proposals to select performing arts shows for the upcoming Festival that will take place in September and the 1st week of October 2019.

Interested parties, artists and organizations from Cyprus and abroad, are invited to submit their performing arts proposals (genres: theatre, dance, music, opera, musical, performances for kids, site-specific performances or any combination of the above) plus proposals for performances in non-conventional venues (street theatre, town squares, etc.).

According to the new Festival procedures, the Artistic Director is also endorsed, to address cooperation proposals directly to acknowledged artistic groups/organizations and artists and/or invite them to submit their proposals or even suggest specific collaborations. The aim is to realize the best possible Festival program, characterized by boldness, innovation and original structure but mainly by quality and aesthetic completeness of its productions.

KYPRIA International Festival aims to present a collection of new performing arts productions characterized by the following:

- a) productions of high quality, which shall elevate the audience's artistic feeling,
- b) productions that display universal values and reflect on social and political phenomena of our time through a timeless approach,
- c) productions that are original and modern by means of conceptions and execution, and
- d) 'outside the box' productions that operate in a controversial but also creative way and cover the whole spectrum of performing arts.

An emphasis will also be given to innovative approaches. The open call for proposals encourages collaborations between Cypriot and foreign artists in order to graft Cypriot

creation with new ideas and approaches. The final Festival program should display its international character.

Local productions that are financed by <u>other institutions</u> (THYMELI program, Ministry of Education and Culture, etc.) will not be accepted for participation in the Festival.

The Artistic Director, who will prepare the final program taking into consideration all aspects, including the available budget and the overall goals of the Festival, will evaluate all proposals and the Director of the Cultural Services of the Ministry of Education and Culture will approve the final outcome.

## PROPOSAL SUBMISSION PROCEDURE

All proposals must be submitted electronically to <u>andy@bargilly.com</u> and Cc'd to <u>mbargilly@gmail.com</u>, by **22 February 2019** and include the following:

- 1. Analytical description of the proposal with
  - a. Reference to the director's approach and the reasoning behind the production (2-3 pages long)
  - b. Duration
  - c. Number of the performances and proposed dates.
  - d. Statement of how the proposal is consistent with the character and goals of the Festival
  - e. Supporting material, i.e. videos and photographs of the actual show (or material from previous shows of the same group/artist in case it is a new production), reviews and any other useful information.
- 2. A complete list of names and CVs of the artists and the names of the technical staff, if any.
- 3. A detailed budget including all production expenses: salaries, rights, fees, production expenses, travel expenses, accommodation, fee of the production office that should not exceed 10% of the total budget (minimum fee 1,000€), per diem, technical support, VAT, sets, etc.
- 4. Short profile of the production office (organization, company, institution or person) submitting the proposal (1 page).

The Festival has the exclusive right to find sponsors.

## AGREEMENT No. \_\_\_\_ FOR STAGING EVENTS AT THE INTERNATIONAL FESTIVAL "KYPRIA 2019"

**The Ministry of Education and Culture,** in charge of organizing the International Festival "Kypria 2019", legally represented by its **Permanent Secretary**, hereinafter referred to as the "**Organizer**,"

both constituting the contracting parties to this Agreement, have agreed and accepted the following:

- The Organizer hereby assigns to the Producer the staging of NUMBER

  Producer.
- 2. In order for the above events to take place, the **Organizer** shall undertake the following:
  - - Amount €\_\_\_\_ (\_\_\_\_thousand euro), approximately one week after the signing of this Agreement (30% of the total amount).
    - Amount €\_\_\_\_ (\_\_\_\_\_thousand euro), one week before the arrival of the company of artists to Cyprus if they are travelling from abroad or three days before the event, if the company is from Cyprus (30% of the total amount).
    - Amount €\_\_\_\_ (\_\_\_\_thousand euro), after the completion of the events, within one months after submission of the accounts (40% of the total amount).

(b) To secure the venues for the staging of the events.

(c) To secure a company for issuing and selling tickets electronically or at predesignated sale points all over Cyprus, at the maximum price of €10.00 (ten Euros) each and at a minimum price corresponding to 50% of the price of the normal ticket. The net ticket sales revenue, or part of it, will cover the third instalment of the production office fees. In case this amount is not sufficient to cover the agreed third instalment, the Ministry of Education and Culture will cover the difference.

(d) To supply the Producer with 20 invitations for his/her own purposes.

The **Producer** shall undertake the following:

(a) To secure the above troupe under the specifications stated in the submission form of his proposal, as approved by the **Organizer** for the events (deviations/differentiations shall not be accepted unless there is strong justification (sickness/accident, war, force majeure, etc.). Any deviation or differentiation without strong justification shall impact on the final amount of the grant).

- (b) To secure and present with proof, before signing the contract, the permit for public performance of the work presented, by an authorized person or organization in relation to the intellectual rights arising from the work, its translation (where applicable), its music and in general all things in connection with which its use in public performance provides for the payment of such rights. Any charge in relation to securing these rights shall be borne by the **Producer**.
- (c) To pay all fees and allowances required for carrying out the above events.
- (d) To make arrangements for air tickets, accommodation, meals, daily allowances and the travelling of the troupe within Cyprus, and to undertake all expenses for the above in case where the troupe comes from abroad.
- (e) The responsibility and the expenses for the technical support of the events, such as lighting, sound, stage sets, dressing rooms etc., as well as any transportation of scenic elements from abroad and their customs clearance and transportation within Cyprus, shall be borne by the **Producer**
- (f) The Producer is obliged to pay, as needed, pursuant to the law, the required income tax and Value Added Tax, both for himself and for the artists from abroad as well as the Entertainment Tax.
- (g) To supply the Artistic Director of the Festival, within two weeks at the latest from the date of signing of this Agreement, with information and advertising material, CVs, reviews, photographs etc. The **Producer** shall be responsible for the editing and translation of the texts to be delivered. In case of non-compliance with the deadline, a sum of €100 per day shall be deducted from the total amount of remuneration. The texts to be delivered shall be in Greek and English. Also, if the Producer desires, he can print his own individual program for the performance, and this will be done at his own expense. The programme must be approved by the Artistic Director.

- (h) The responsibility for the smooth running of the above events and the departure of the members of the troupe, as well as the health and safety of those involved in the performance according to the law (actors, artists, dancers, technicians etc.) both during the performance and the rehearsals and setting up at the venue. It is clarified that the time for the start of each performance will be determined by the Artistic Director (the time will be clearly stated in the Programme and on the Tickets). The Producer shall not have power to alter and/or prevent the opening of the performance at the time specified, for any reason.
- (i) The Artistic Director must be able to attend rehearsals and/or receive constant briefing in connection with the progress of preparations. He shall also be entitled to monitor compliance with the agreement as regards the contributors and the content and the way the production is presented in general.
- (j) The deposit of a guarantee in the form of a bank guarantee or personal cheque for an amount equal to 10% of the total amount agreed [section 2(a)] for the participation of the troupe in the International Festival "Kypria 2019", made payable to the name of the Permanent Secretary of the Ministry of Education and Culture. The guarantee will be returned 30 days at the latest after the events have taken place.
- 4. In case of wrongful breach of contract by either contracting party, the culpable party shall be bound to return immediately any amounts received in the form of and advance or partial payment under this agreement and/or to indemnify the other party for damages incurred by this occurrence. If the two parties fail to come to an agreement, the dispute shall be settled by the courts of Cyprus.
- 5. Any amendment to the above terms, which are all considered essential, must be evidenced by a new agreement in writing.
- 6. This agreement has been drawn up in two original copies, which are signed by the contracting parties and each contracting party (the **Organizer** and the **Producer**) has received one copy.
