

## General conditions

for a subsidy to participate in the EYE 2014  
as an *Opinion Multiplier Group*



In the context of the European the European Youth Event 2014, the Visits and Seminars Unit of the European Parliament will have limited means to sponsor groups that will actively contribute to the preparation and the programme of the event.

To apply for such a subsidy, a number of conditions have to be met.

### General criteria for provision of a subsidy:

1. The participant(s) must be citizen(s) of the European Union or national(s) of candidate countries and must be between 16 and 30 years of age.
2. A minimum of 10 and a maximum of 40 persons per group can be subsidised.
3. The subsidised group must take on opinion multiplying activities upon its return and provide the Visits and Seminars Unit with proofs (articles in newspapers, facebook, blogs, exhibitions, seminars etc.) within 6 months following the event.

### Additional criteria (fulfilling one of the following three is enough)

1. The group will prepare and develop a genuine, original contribution related to the motto of the event, "**Ideas for a better Europe**"
2. The group will have an active cultural contribution to the **Street Festival**, organised during the evening of Friday 9 May 2014, in the old city of Strasbourg (i. e. theatre play, music or dance performance, stand-up comedy etc).
3. The group intends to come with a **partner group/organisation** from another EU country (using twinning partners, school partnerships or newly established contacts).
