The master's degree offered in China is conducted in English and plays an important role in stimulating economic cooperation between China and the recipient's home countries.

Recipients for the **MOFCOM Scholarship** are **ONLY** accepted from relevant government ministries under the following criterion and procedures.

- 1) Applicants shall get approval and recommendation from relevant ministries of their home country, such as the Ministry of Education, Ministry of Technology, Ministry of Environment, etc., to foster the official bilateral communication between two countries.
- 2) The application shall be directly submitted to the Economic and Commercial Counselor's Office (ECCO) of the Chinese Embassy in the applicants' home country.
- 3) The Economic and Commercial Counselor's Office would evaluate the application documents and conduct an interview accordingly.
- 4) Then the applicant can be considered for the scholarship and only if done within the stipulated application period **on or before 16**<sup>th</sup> **November 2021** (for more information on the application process *please see the attached brochure*).

The application will close on **16 November 2021.**
